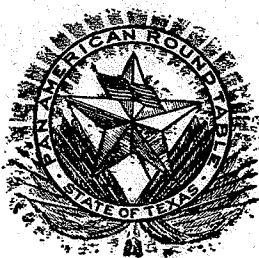

*Dear Betty -*

The dates for the State Convention of Pan-American Round Tables have been set for April 5, 6, 7, 1961, with a Board Meeting on the evening of April 4. As you know, the place is Corpus Christi and the headquarters will be at the Driscoll Hotel. Mrs. Richard Kleberg, Box 636, Corpus Christi, is the convention chairman.

I feel that it is now time for the State Officers to give thought to setting up the agenda of business for the convention and other questions that are within the jurisdiction of the Board. May I suggest and hope for an early reply to:

1. Theme of Convention, "Understanding through Study."
2. A work shop or School of Instruction for officers of Tables.
  - a. Such instruction to be given by Associate Directors and the other officers of the Board.

(Many Tables do not know of the duties of the Associate Directors and consequently never ask advice of same, nor invite them to Table meetings in an official capacity.)

- b. A work shop on programs designed primarily for program chairmen stressing.

1. Special attention and consideration of Article II of Constitution.
  2. Current news of Pan-American Countries.
  3. Study of flags and the countries which they represent.

3. A review of Constitution and By-Laws with particular thought and study as to Page 1, Article III, Section 2, and specifically the terms, "Non-Commercial" and "Non-Profit Sharing."

I find that many tables conduct money raising projects. Most of these are for their scholarship funds, or for defraying the expenses of delegates to Conventions. Since the organization does sponsor scholarships and does recommend that delegates attend conventions, the two above mentioned might well fall within the realm of a Table's privilege. But it is my feeling that profiting through Tour Agencies and raising funds for a Club house and other such projects are not covered by said section of Constitution and By-Laws.

Further, the charter granted by the State of Texas gives the organization non-profit status, exempt from payment to the Department of Internal Revenue, and thereby special mailing privileges for our publications.

I feel sure that many of you will have some special points and ideas worthy of consideration. So please feel free to write me, as I plan to go to Corpus Christi to meet with Mrs. Kleberg in late summer or early fall. I am moving to another apartment on June 1, and my new address will be 1200 W. Yandell Blvd.

TO THE PAN AMERICAN ROUND TABLES OF TEXAS:

In just three months the Texas Pan American Round Tables will be meeting in their biennial session for discussion and solution of common problems, business, and election of State Officers for the ensuing two years.

We--the members of the Nominating Committee--are asking each Table to submit to us the names of members who can, and will, serve as state officers for the two years following the Corpus Christi Convention in April.

The State Constitution decrees that no officer shall succeed herself, so each office must be filled anew. The individual Texas Tables have so much fine material that your State Nominating Committee is asking each one to send in the names of their members who will be available to fill the following offices: State Director, four Associate Directors (one from each of the four quadrants of the State), Corresponding Secretary, Recording Secretary, Treasurer, Historian, and Parliamentarian. The duties of each of these officers are outlined in Article I of the By-Laws of the State Constitution.

When sending in names of candidates, please include along with the name and address of the Table member, her qualifications for the office (or offices) for which you propose her name. And please be sure that she will accept the office and its duties for which her name is being submitted. From these names sent us, the committee will choose a slate of officers and submit it to the Convention. And it is our heartfelt hope that the names of so many possible candidates will be submitted to us from all the Tables that, for the first time, the committee members may enjoy the business and fun of the Convention with their report ready to be posted at the opening of the first session!

Again--a last request--PLEASE be sure that the member(s) whose name(s) you send to us will serve in the capacity for which she is nominated. The members of the committee are geographically distributed through the State in case your Table would like to confer with a committee member in the table's area.
