ARTICLE II \* LOCATION OF OFFICE  
THE location of the principal office of the corporation shall be at \_\_\_\_\_, in \_\_\_\_\_ county, Texas

The property and business of the corporation shall be managed and controlled by a board of seven trustees, all of whom shall be members of The Pan American Round Tables of Texas. Four of the trustees shall be the State Director, the First Associate Director, the Treasurer, and the immediate Past State Director of the Pan American Round Tables of Texas, and such trustees shall hold office as trustees so long as <sup>they</sup> hold respectively such offices in the Pan American Round Tables of Texas. The remaining three trustees are the representatives of the three Tables of the Pan American Round Tables of Texas constituting the Committee on Scholarships as set up in the Constitution and By-Laws of the Pan American Round Tables, each of which serve for a period of six years, appointed by the State Director. If any trustee appointed by the State Director, before her term of office as such appointed trustee expires, becomes one of the four officers of the Pan American Round Tables of Texas herein listed who shall be ex officio trustees of the corporation, then the place of such appointed trustee, upon her becoming such ex officio trustee, shall become vacant and such vacancy shall be filled as provided in Article VI of these by-laws for filling vacancies among the trustees.

ARTICLE IV - POWERS OF TRUSTEES

The Board of Trustees shall have the general power to administer the affairs of the corporation and to formulate and carry out its program and policies. The Board of Trustees shall exercise over the management, acquisition and disposition of the property of the corporation, shall supervise the financial administration of the corporation, and exercise such additional powers and authority as may be proper under the laws of the State of Texas applying to such corporations consistent with the purposes of said corporations as stated in the Articles of Incorporation. The Board of Trustees shall report to the State Board of The Pan American Round Tables at the annual meetings of Said Board on the program and policies of the Foundation.

ARTICLE V - MEETINGS OF TRUSTEES  
The Board of Trustees shall meet at regular annual meetings at a time mutually agreed upon by the trustees. Additional regular meetings may be scheduled by a majority vote of the Board of Trustees at such times and places as may be provided in the resolution providing for such meetings. Special meetings may be called by the Chairman of the Board of Trustees or by a majority of the Board of Trustees at such time and place as may be designated by the Chairman of the majority of the Board of Trustees at such time and place as may be  
Written notice

Written notice of special meetings of the Board of Trustees shall be mailed to each member of the Board of Trustees not less than two weeks prior to the date of such special meetings.

ARTICLE VI - VACANCIES

Any vacancy occurring in the Board of Trustees among the three trustees who are appointed by the State Director shall be filled by the State Director observing the rotation of the Texas Tables as provided for in the State Constitution and By-Laws, of the Pan American Round Tables of Texas. Vacancies occurring among the Board of Trustees among the four trustees who hold office as trustees by virtue of being officers of The Pan American Round Tables of Texas shall be filled only by their successors as provided for in the Pan American Round Tables of Texas.

ARTICLE VIII - OFFICERS

THE officers of the corporation shall consist of a President, who shall be the State Director of the Pan American Round Tables of Texas, the Vice - President, who shall be the First Associate Director of the Pan American Round Tables of Texas, a Secretary, who shall be chosen by the Board of Trustees, and a Treasurer, who shall be the Treasurer of the Pan American Round Tables of Texas. The President of the corporation shall be the Chairman of the Board of Trustees of the Corporation. The Secretary of the corporation shall be the secretary of the Board of Trustees. The officers shall have such duties and authority as are usually attached to each of their offices and shall have further duties and authority as may be designated from time to time by the Board of Trustees.

Article VI - QUORUM OF TRUSTEES

A majority of the Board of Trustees shall constitute a quorum for the transaction of business, and the action of the majority of the trustees present at a meeting at which a quorum is present shall be the action of the Board of Trustees, except as to amendments to the by-laws, as hereinafter provided.

ARTICLE VIII - COMMITTEES

The Board of Trustees, by resolution adopted by a majority of the trustees in office, may designate one or more committees of trustees, each of which committees shall consist of two or more trustees. Among other committees there shall be the Executive committee, composed of the three trustees who are the representatives of the three Tables on the State Scholarship Committee, which Executive committee shall have the power and authority of the Board of Trustees in the management of the corporation between the meetings of the Board of Trustees. All actions of the executive committee shall be reported at the next meeting of the Board of Trustees.

ARTICLE IX - FINANCIAL ADMINISTRATION

The Board of Trustees of the Corporation shall receive such property and funds as may be contributed from time to time by The Pan American Round Tables of Texas, or by other sources and shall administer for the advancement of the purpose of the corporation. The Board of Trustees shall have the authority to accept or reject on behalf of the corporation, any contribution, gift, bequest, or device for the general purposes of the corporation. It shall give approval to all investments and all disbursements of funds, and establish procedures to delegate authority to the officers for the investment of the funds of the corporation. It shall have authority to approve the payment from the funds of Foundation of expenses incurred in administering the program of the corporation and in holding meetings of the Board of Trustees. The fiscal year of the corporation shall be from May 1 to April 30 of the succeeding year.

BY - LAWS OF THE FLORENCE TERRY GRISWOLD EDUCATIONAL FUNDATION ( con't.)

ARTICLE XI - DISSOLUTION

In the event that either by vote of the trustees or by legal action or otherwise, this corporation is dissolved, its assets after the payment of all outstanding obligations shall be transferred and delivered to such other non-profit corporation or non-profit organization <sup>by legal</sup> qualified under the Internal

Revenue Code as will carry out the purpose and policies set forth in the Articles of Incorporation of this corporation. In any event no part of the remaining assets of the corporation shall inure to the benefit of any private individual, or to any one Table of the Pan American Round Tables of Texas.

ARTICLE XII - AMENDMENTS TO THE BY- LAWS

THESE By-Laws may be amended by the Board of Trustees, provided that two-thirds of the entire Board of Trustees shall vote in favor of such amendment, and that a written proposal for the amendment has been sent to all trustees at least one month before the vote is taken on such amendment. All voting on amendments shall be done when board is in session.



Articles of Incorporation of  
The Florence Terry Griswold  
Educational Foundation

We, the undersigned natural persons of the age of twenty-one years or more, all of whom are citizens of the State of Texas, acting as incorporators of a corporation under the Texas Non-Profit Corporation Act, do hereby adopt the following Articles of Incorporation for such corporation.

ARTICLE ONE

The name of the corporation is The Florence Terry Griswold Educational Foundation.

ARTICLE TWO

The <sup>C</sup>orporation is a non-profit corporation.

ARTICLE THREE

The period of its duration is perpetual.

Article Four

The purpose for which the corporation is organized is: to provide scholarships for women from the Latin American countries of the Western Hemisphere to study in the State supported schools of Texas. This purpose shall not include any power which will cause the corporation to fail to qualify as an organization exempt from federal income taxation under the Internal Revenue Code of 1954 or any subsequent Internal Revenue law.

ARTICLE FIVE

The corporation is to have no members.

ARTICLE SIX

No part of the net earnings of the corporation shall inure to the benefit of any private individual and no part of its activities shall be the carrying on of propaganda or otherwise attempting to influence legislation and the corporation shall not participate in, or intervene any political campaign on behalf of any candidate for public office.

ARTICLE SEVEN

Upon final dissolution or liquidation of the corporation and after discharge or satisfaction of all outstanding obligations and liabilities, the remaining assets of the corporation shall be conveyed, transferred, or assigned to a corporation or other organization <sup>of Texas</sup> qualified under the Internal Revenue Code to carry out the purposes and policies set forth in these Articles of Incorporation, and which corporation or organization will be then exempt from federal income taxation under the Internal Revenue Code of 1954 or any subsequent Internal Revenue Law.

ARTICLE EIGHT

The State Board of the Pan American Round Tables of Texas met January 24, 1964 at 9:30 a.m. in the Hamilton Hotel, Laredo, Texas, with Mrs. Clyde Trotter, State Director, president, and 14 members including two past Directors present, constituting a quorum. Those present were:

Mrs. Lester Whipple was invited to sit in the session as a guest of the Board, representing her committee, the Resolutions Committee.

Mrs. Trotter gave a word of welcome from the city and the local PART, and her own personal greeting.

Mrs. Wylia moved, and it was seconded, that the informal agenda be accepted as presented. The motion carried.

The Informal Reports were presented:

Mrs. Brown, as Associate Director and Chairman of Extension Work, reported her visitations. A formal application for a new Round Table, Las Amigas Pan American Round Table of Fort Worth was received, and all requirements found to be satisfactory in accordance with the State Constitution.

Mrs. Ely moved and Mrs. Cunningham seconded, that the newly organized Table in Fort Worth be accepted as Pan American Round Table II of Fort Worth. The motion carried.

Mrs. Brown reported a Table in Beeville in the process of organization.

Mrs. Hillis, Chairman of Area II, Mrs. Fernandez, Chairman of Area III and Mrs. Gale, Chairman of Area IV, had nothing to report on extension work, and possibilities of forming new Tables were discussed.

Mrs. J. T. Watt as Corresponding Secretary reported her correspondence.

Mrs. Richard Singer, as Historian, reported her difficulty in securing news items and asked for suggestions.

Mrs. Harmon, the Parliamentarian, suggested that there be incorporated into the Standing Rules a provision that additional Tables must carry a number in the name, as stated in the framework of the Constitution.

The Treasurer's report, sent by Mrs. William K. Miller was read by Mrs. Harris, and reported a balance of \$9,104.37 in the State Fund, and \$2,177.11 in the Griswold Fund.

The Budget Committee, consisting of Mrs. Wylie, Mrs. Brown and Mrs. Fernandez, was appointed, and instructed to present the budget in the morning session, January 25, 1964.

Mrs. Trotter presented her report: (1) representatives from every Table were given a place on the Board: they were elected, appointed or named on Committees. (2) The Treasurer's bond was raised to \$10,000 to cover the permanent account. (3) A formal protest was sent to the Alliance because of errors in minutes at the last Convention in Mexico City; not in criticism, but because of what the Texas Tables stand for. There was no official reply from Mrs. Suarez because of illness, but Mrs. Nelson, Alliance Associate Director, Mrs. Peterson, Chairman of the Publicity Committee, and Sra. Aurora Lopez, Alliance Corresponding Secretary replied.

Mrs. Trotter reported replying to letters of condolence received after the assassination of President Kennedy. A letter of congratulations from the State was sent to Mr. Thomas Mann upon his appointment to Latin American activities for the State Department. Visitations were reported.

Mrs. Nobles, Chairman of Archives, moved, and it was seconded, that the Board consider storing the archives at St. Mary's University because of their ability and interest in preserving them.

Mrs. Trotter proposed that because of the seriousness of the decision, the original motion be tabled until the morning session. Motion carried.

Miss Hatfield, as Chairman of Education, reported no plans for the State at this time, and asked for suggestions.

The morning session adjourned at 11:40 a.m.

Mrs. Trotter entertained the State Board with a luncheon in the El Nopal Room of the Siesta Motel and had gifts of orchids grown by Mrs. Hunt of the Loreda Table, as prizes.

Afternoon Session - - - January 24, 1964

The meeting was opened by the State Director, Mrs. Clyde Trotter, at 2:30 p.m. Mrs. A.V. Peterson of Rio Grande City, Chairman of the Friendship Committee, joined the business session of the afternoon.

Mrs. Cunningham, Interchange Library Chairman, read a Supplement to the Report of the 1963 Committee: the project accomplished much toward better understanding with our sister Tables. Mrs. Cunningham asked for ideas.

Mrs. Trotter read a request from Mrs. William Kay Miller of the Austin Table for books for



a special room in the new library of the University of Chile in Santiago, and a plaque stating that they were a gift of the PART of Texas.

The report of the Chairman of the Publications Committee was read by Mrs. Harris.

Mrs. Wylie moved and it was seconded, that a note of appreciation for the excellent work with Texana be sent to Mrs. Watson and Table III of Dallas.

Mrs. Vaughan, Chairman of the Scholarship Committee, was not present. There was a general discussion of information available for a project.

Mrs. Trotter has appointed a new member, Mrs. Harry Jarrett, of Dallas 1 to the Scholarship Committee.

Mrs. Peterson, Chairman of the Friendship Committee, urged that we form our friendships on a personal basis with the Latin American countries.

Mrs. Harmon moved and it was seconded, that because of lack of notification the Tables not be penalized for non-payment of dues before November 1. Motion carried.

The meeting adjourned at 4:00 p.m.

At 5:00 p.m. a Merienda was given by the Executive Board of the PART of Laredo in the lovely home of Mrs. O. L. Longoria in Nuevo Laredo, Tamaulipas, Mexico.

January 25, 1964

The morning session convened at 9:15, with 16 members present to form a quorum, with Mrs. Trotter presiding.

Mrs. Wylie presented the budget for \$650.00 and moved to have it accepted. It was seconded and motion carried.

With Mrs. Brown presiding, Mrs. Watt, the Corresponding Secretary, and Mrs. Trotter, presented their office bills. Mrs. Fernandez moved and Mrs. Harris seconded that the bills be accepted and ordered paid. The motion carried.

The names for the nominating committee were presented. Mrs. Singer moved that the following committee be accepted by acclamation. Mrs. Watt seconded. Mrs. Ely amended that this be done following precedent. This was seconded and the amendment carried. The motion carried.

Mrs. Gale, Chairman of the State Convention in El Paso, reported that Hotel Paso del Norte will be Convention headquarters; the Convention dates will be April 6, 7 and 8, 1965.

Mrs. Cunningham moved, and it was seconded, that the Archives be left permanently in San Antonio, according to the Constitution. Mrs. Nobles moved, and it was seconded, that we

place the Archives in St. Mary's University Library. Mrs. Nobles would obtain a letter from St. Mary's University with a statement signed by the Library Director and the President of the University, that the Archives would be left intact, before any formal commitment is made. The letter should be kept in the hands of the Chairman of Archives, with a copy of it in the Director's file and another in this administration's file.

Mrs. Harmon moved, and it was seconded, that the letter be run in Texana so it would be a matter of public record. Motion carried.

Mrs. Harmon moved, and it was seconded, that letters of appreciation be sent to:

With Mrs. Brown presiding, Mrs. Trotter presented her recommendations:

1. Continuity of State Work at Local level until the Board meeting. Mrs. Watt moved its adoption and it was seconded. Motion did not carry. Mrs. Ely moved that each officer and Committee Chairman keep a written record to present to the incoming officer. It was seconded and carried.
2. That the 4 State Areas be redefined and adjusted to representation of membership. Mrs. Cunningham moved and it was seconded that the Director and the Associate Directors be appointed to redefine the areas as they see fit. Motion carried.
3. That Texas Tables invite into their homes a Table from the Alliance and include a meeting of the local Table in order to promote friendship. Mrs. Harris moved and it was seconded that we approve the thought behind the suggestion. Motion carried.
4. That we permit the organization of State work-shops for the general membership. Mrs. Hillis moved and it was seconded that the recommendation be approved. Motion carried.

Instructions from Mrs. Trotter as Director;

1. That we seek every chance of presenting our work to the public.
2. To Chairmen of Committees, the backbone of the State organization: write to each one on your committee what we did at the Board meeting and ask them to participate in any discussion when presented to the Table.

Mrs. Ely moved and it was seconded, that we express our confidence in our Director in any action she may see fit. Motion carried unanimously.

Mrs. Trotter proposed that we remind our Tables of the Alliance Convention in Peru in the last days of May and bid them be very thoughtful of the delegates sent to represent us.

The minutes were read approved as corrected and filed.

Adjournment at 11:45 a.m.

The Board was given a luncheon in the Maya Room of the Hamilton Hotel by the Laredo PART after the business session.

### Pre-Convention Board Meeting

The Pre-Convention Meeting of the State Board of Directors was held April 5 at 4:00 p.m. in the Spanish Room of the Hotel Paso del Norte in El Paso, Texas, with the State Directors, Mrs. Clyde Trotter, presiding and 16 members present, including 4 Past State Directors.

The Director opened the meeting with a reading of Robert Louis Stevenson's poem "A Prayer".

Mrs. Trotter presented the Chairman of the Convention, Mrs. Wyndham K. White, and the Co-Chairman, Mrs. Newton F. Walker, who gave greetings and asked for five minutes of instruction to the members before the end of each meeting.

The Director asked each member of the Board for a report.

The Corresponding Secretary, Mrs. J. T. Watt could not be present and Mrs. A. R. Hunt sat in as pro-tem officer to read some reports.

The Treasurer, Mrs. William K. Miller sent her report and Mrs. Milton Overstreet will read it.

First Associate Director Mrs. Hart Brown reported two new Tables: Fort Worth II accepted at the January Board Meeting, and the Beeville Table accepted before the Alliance Convention in Lima Perú. There is the beginning of a Table in Galveston.



Second Associate Director Mrs. Albert Fernández reported giving a Charter at the December meeting to the Beeville Table.

Third Associate Director Mrs. Hugh Hillis as Area B Director reported participating in both workshops and an area get-together at Houston.

Fourth Associate Director Mrs. Arthur Gale reported no new Tables in the area, and asked for contacts from the members.

The Corresponding Secretary's communications were read by Mrs. Watt:

A letter from Mrs. J. W. Worthington with good wishes.

Greetings from Mrs. Lula George, Brownsville I; Mrs. Norton, Conroe I;  
Mrs. Milton McGee, Conroe II.

A note from the Corresponding Secretary of the Alamo-San Juan Table requesting a change in the name of their Table to Alamo-San Juan-Pharr.

Mrs. Ely clarified that the area is known as a consolidated district and the change is merely a matter of explaining the area.

Mrs. Ely moved that the change be made; it was seconded and carried.

Mrs. Hunt read a report from Mrs. Watt, for secretarial expenses, directives and convention call. Mrs. W. W. Hawkins moved and it was seconded that the expense account be accepted and paid. Motion carried.

The Parliamentarian, Mrs. Frank Harmon, reported assisting with the workshops at Edinburg in October and at Corsicana in December.

The Director, Mrs. Trotter, suggested that since at the last two State Conventions Florence Terry Griswold awards have been given for outstanding work to the Pan American Round Tables of Texas, she would like to present for adoption the guide-lines for this award.

Mrs. Trotter appointed Mrs. Nobles to serve as Chairman of the Forence Terry Griswold Award Committee at this Convention. Her report will be made at the Installation Luncheon.

It was agreed that to designate the State Director's pin from that of the Table Director's that a blue stone or set be placed, if it is possible, in the center of the star.

Historian Mrs. Richard Singer reported assembling the clippings, and had a suggestion: That the Historian of each Table assemble her own clippings about the individual Table.

The Archives Chairman, Mrs. Nobles, reported there is no collection of individual scrapbooks in the Archives from the past. She suggested that pages should be of uniform size, for the present equipment is not very spacious. The State Archives should be a history of the State Board Meetings and Projects and special events corresponding to State Officers and the Convention. The Tables would keep their own clippings unless it was State history.

Mrs. Nobles moved to adopt the suggestion. It was seconded and carried.

Past State Director Mrs. A. J. Wylie discussed her workshop and expressed a desire to have the Officers and Committee Chairmen present to suggest how the work could be furthered.

Mrs. Trotter suggested that workshops are very worthwhile and a New Director's workshop under the supervision of the Immediate Past Director should be instituted.

Mrs. Wylie moved that the Board adopt the New Director's Workshop and make it a permanent part of the State Convention. It was seconded and carried.

Archives Chairman Mrs. Nobles reported that the Archives are in good hands at St. Mary's University Library and will comprise a complete history of our movement from the beginning.

Education Chairman Miss Sadie Hatfield sent no report.

Friendship Chairman Mrs. A. V. Peterson was not present. (See Officer's report file.)

Interchange Library Chairman Mrs. Michael Cunningham reported sending The Reader's Digest in Spanish to 45 Table Directors in Latin America from individual Tables.

Nominating Chairman Mrs. W. W. Ely reported her committee at work to present a good slate to the Convention. She reported poor response from Tables to her request for candidates. These recommendations should come from Tables, not individuals.

Publications Chairman Mrs. James W. Watson reported publishing and sending 4 issues of the Pan Americana Texana and will send a Post Convention issue.

Resolutions Chairman Mrs. Lester Whipple reported a Resolution from Miss Harvey of Fort Worth I which will be read later, and is preparing the Courtesy Resolutions.

Revisions Chairman, Mrs. Frank Harmon proposed a Revision to the Constitution from the Austin Table. An amendment change from the Florence Terry Griswold Scholarship Fund to a Foundation subject to approval of the Board and also to two attorneys. The change is necessary in order to meet the regulations of the Internal Revenue Service.

The change would be to the By-Laws, Article 5 to cover this incorporation.

Mrs. Trotter would like for the Board to recommend to the Body that further study be made. The change should be worked out by a committee to be brought back to the Board, printed and in suitable form.

Mrs. Brown moved that Mrs. Trotter be empowered to appoint a study group for this amendment and that she be an ex-officio member and later a member to bring a report next year to the Board Meeting of the possibility of establishing a Griswold Foundation. It was seconded and carried.

The current bills of the Director's office were moved paid.

Mrs. Trotter declared a great need for a Protocol Officer. She recommended that there be a Protocol Officer to supervise meetings at the individual Tables so that the office and not the person be honored. Special mention should be made of it at workshops. It was so moved and seconded. The recommendation and the motion were adopted.

The Director recommended continuity of certain State projects: Education, Interchange Library and Friendship, to give continuity to State Work. After discussion, since no agreement could be reached, The Chair entertained a motion that the meeting take up the recommendation after dinner. Mrs. Cunningham moved and it was seconded and carried.

The Chair entertained a motion for a recess. Miss Halliday so moved and it was seconded.

The body recessed for 10 minutes.

There was a report from the Revisions Committee requesting a change in the name of the Florence Terry Griswold Fund to the Florence Terry Griswold Foundation, as presented from the Austin Table. The Board referred this to a Study Group Committee to study it further and later bring the results to the Convention.

Mrs. Harmon moved rejection of this amendment for revision at the present time. It was seconded and the motion carried.

The Director, to clarify the Board action, stated that with due legal counsel, it was found that we must get incorporated in order to establish the Foundation.

She named Mrs. Geyer of Dallas I and Mrs. Florence Johnson Scott of Rio Grande City to serve with her on this Committee for presentation of plans at the Board Meeting in 1966.

The Chair entertained invitations to the 1967 State Convention. She recognized the Directors of the Dallas Tables, Mrs. Robertha Geyer of Dallas I; Mrs. Jack Trigg, Dallas II; and Mrs. Charles S. Yancey of Dallas III, who invited the Convention for 1967.

Mrs. Michael Cunningham moved, and it was seconded, that we accept the invitation. The motion carried.

Mrs. Lester Whipple, Chairman of the Resolutions Committee, read the first part of the Resolution presented by a committee of the Fort Worth I Table. The Chair, having been assured that the resolution had been presented and adopted by Fort Worth I ruled part I out of order on #67, Robert's Rules Revised in that it conflicted with the State Constitution because it sought to revise it. Then the Chair, using its privilege or right to make known to the assembled members any additional information they may not have or know, stated it was also out of order on the following points:

- a) The framework Constitution under which all new Tables are formed states in its Article IV, "Affiliation with organization of the Pan American Round Table, National or International, is authorized provided local autonomy is reserved." The Table therefore makes its own choice.
- b) Requiring affiliations outside of Texas is null and void as it is in opposition with our Texas Charter (Legal as well as Robert's Parliamentary Law).
- c) Our State Constitution and By-Laws does not grant us permission to take from a member Table the right, the privilege, or a duty accorded all of us as equal Tables and as equal individual members. The State Board may drop a Table for failing to conform to the State Constitution, but has not the authority to discipline an individual Table or an individual member.

Part II out of order on first count. Our State Constitution requires that the revision of the Constitution and By-Laws be presented in proper form to the Revisions Committee. Furthermore they were both out of order in that a resolution can have only one point. (Roberts)

Mrs. Whipple then presented the Courtesy Resolutions and moved their adoption with the reservation of subsequent additions, if needed. It was seconded by Mrs. Geyer. Motion carried.

Mrs. Scott moved and it was seconded that it be accepted with a rising vote of thanks.

Mrs. Wyndham Kemp White read a personal communication from the Director General of the Alliance.

Mrs. W. W. Hawkins moved that a message be sent to our Florence Terry Griswold awardees. It was seconded and carried. The awardees are:

Presented the narrow band of blue ribbon, the mark of the Award to the recipients present: Mrs. W. W. Ely, Mrs. A. B. Pumphrey, and Mrs. Michael Cunningham. Then Mrs. Cunningham in turn presented Mrs. Nobles her ribbon. There was no Award made at this Convention, since it is not mandatory for the Committee to choose a recipient for the Award.

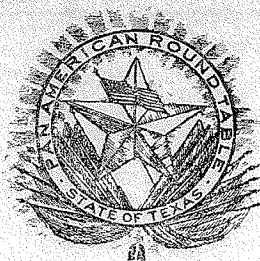
