STATE DIRECTOR'S REPORT



APRIL, 2015

My tenure as PARTT State Director began on Sunday, April 12, 2015 when I was installed by Sarah Jane Wise, Past PARTT State Director. The first order of business was to appoint the following committee chairs:

I then appointed committee members to each of these committees:

Resolutions Committee: Gloria Munguia and Lucy Mancha Revisions Committee: Woody Hearn and Frances Rodriguez

The two Ad-Hoc Committees from the previous administration continued with:

Ruth Kulessa: PARTT Book with committee members Yollie Calley and Ahia Shabaaz Janet Roberts: PARTT Historical with committee members Deena Bird and Toni Ruiz

I then created a new Ad-Hoc Committee: Membership Committee with the purpose of seeking ways to increase and maintain our membership in the PART. Carmen R. Guerra was appointed the chair with committee members Gloria Riddle, Carmen Guerra, Jessica Farrell, and Espernza Deutsch.

Once the committees were in place, I reached out to the Tables across Texas to get a listing of the new Table Directors for the year 2015-2016 and began communications with them. I invited them and the PARTT Board and Committees to a PARTT workshop at the Marriott NW on Saturday, August 15, 2015. The purpose of the workshop was for orientation and a chance for committee members to meet and join in a dialogue. I contacted the Marriott NW and set up the arrangements.

I sent out to the PARTT Board and the Table Directors all the contact information I had received.

On April 25, 2015, I attended the lower Valley Pan American Observance Day held in Harlingen. After the celebration, I met with Lana Harper, Immediate Past State Director, to receive her binder and box of information.

MAY, 2015

On May 12, 2015, I filed the nonprofit periodic report with the Texas Secretary of State (Form 802) and paid the \$5.00 fee.

May 14, 2015, I installed the new executive board of Alamo/San Juan/Pharr PART using a birthday theme to encourage everyone to begin the 100th celebration of the Pan American Round Table.

I continued to negotiate with the Marriott NW for the summer workshop. I reserved 15 hotel rooms and the meeting room for the workshop.

JUNE, 2015

On June 1, 2015 I filed the PARTT 990N e-postcard and wrote to the Table Directors to do the same.

During the month of June & July, I began preparations for the summer PARTT workshop. I ordered name badges for the entire PARTT Board and completed binders with all the information needed by the Table Directors and board members. Many of the Board and Table Directors were in attendance. State Committee members had a chance to meet each other and to meet as a group.

I was approached by Louise Actkinson about the restoration and re-dedication of the tablet (marker) on the Laredo International Bridge #1. The marker was in very bad condition. Louise had hoped to restore the marker as a Convention project but was advised that it needed the blessing of the PARTT Board and that it should be a project for them. I began my research and decided to bring the project to the PARTT Board at a special meeting to be held at the start of the summer workshop in San Antonio.

JULY, 2015

On July 27, 2015 I contacted the City Manager of Laredo to find out who indeed owned the Laredo International Bridge #1.

On July, 30, 2015, I received a letter from the City Manager of Laredo, Jesus M. Olivares, stating that the City of Laredo owned the bridge and that we had permission to remove, restore, and re-install the PARTT marker on the Laredo International Bridge #1.

AUGUST 15, 2015

The summer workshop was held in San Antonio on August 15, 2015. PARTT Board members and committee members as well as Table Directors and Table ECC Chairs were in attendance. Prior to the workshop, a special PARTT Board meeting was called to discuss the restoration of the PARTT Tablet on the Laredo International Bridge #1. The

PARTT Board unanimously voted to proceed with the project. Donations were collected for the restoration project.

OCTOBER, 2015

On October 6, 2015, I attended Founder's Day in McAllen. Many of the ladies from across the Rio Grande valley were in attendance.

On October 21, 2015, I attended Founder's Day in Edinburg.

On October 24, 2015, I wrote the IRS for a determination letter.

NOVEMBER, 2015

On November 7, 2015, I presented the history of PARTT to the South Texas Historical Meeting held at the Brownsville Historical Heritage Complex. The presentation was well received. On that same day, I attended the birthday celebration of PART I of Brownsville.

It was a very productive meeting. The article "Dames of the Round Table" was featured in the Spring 2016 issue of the magazine.

On January 30, 2016, I filed the subsidiary report with the Internal Revenue Service

FEBRUARY, 2016

On February 3, 2016, I hosted a meeting with Area C Table Directors and Louise Actkinson, Alliance Convention Chair, for the purpose of helping Louise with the Alliance Convention being held in San Antonio in October, 2016.
