STATE DIRECTOR'S REPORT TO THE PARTT BOARD

Brownsville, Texas - March 25, 2006

It has been an amazing and rewarding year for me. Thank you so much for the honor of representing you as State Director. I have visited 18 of our 21 Texas Pan American Round Tables and am scheduled to visit the last three – Dallas III, Fort Worth I, and Fort Worth II – on April 12th.

So much of my travel has been via Southwest Airlines. I found it less expensive than traveling by car even at the \$.30 a mile allotted for travel. There have been many flights out of Harlingen at 6:40 AM with return flights in the early evening. I traveled to Austin, San Antonio, and Houston in this manner. My trips to Odessa and El Paso were over night ones. The trips to Laredo, Eagle Pass, Del Rio, and Conroe were made with my husband Dick and Rowdy, our Border Collie. Bev Parker, State Corresponding Secretary accompanied me on my trips to Houston. McAllen, Beeville, Rio Grande City, Edinburg, Alamo/San Juan, Pharr, San Benito, Corpus Christi.

Margie Rogers, First Associate Director, represented me at the Alliance Board Meeting in Acapulco on July 4, 2005 because I had other commitments on that date. I appreciated Margie's willingness to do that and appreciated the very detailed report that she wrote of that meeting.

The officers and members of each Table were very gracious and welcoming – making my visits with them pleasant and informative ones. I installed the officers of the tables in Corpus Christi, San Benito, and Brownsville II and will install the officers of Brownsville I in June. I reviewed the Constitution and

By-Laws of all but one of our Tables and found that they were in compliance with our State Constitution and By-Laws. I now have Financial Reports from all but two of our Tables and I continue to pursue those.

A special concern of mine has been the declining membership of our Tables. I talked about this with the membership of the Tables when I visited and left brochures

with them that the could share with prospective members or new members.

The brochures were developed by Margie Rodgers and her Long Range Committee and were included in the report to the Board in El Paso. I modified them slightly and brought them up to date. Although some of our Tables are doing very well with membership, others are not. Some are limited by the space in the places that they meet. Others have a cap on their membership and may have a waiting list. Some are content with the status quo and are quite selective in their inclusion of a few new members. The larger the membership, the more new members are included. The smaller the membership, the fewer new members are introduced. Once the membership of a Table declines, it becomes more of a challenge to rebuild the numbers. Although I have made an effort to solve some of these problems, I am not sure that I have made a difference. Perhap time will tell.

On a positive note, although all of our Texas Tables are different, they do share the same objectives and ideals that make the Pan American Round Tables of Texas the great organization that it is. I have come to appreciate and enjoy these differences. And as I have talked with the individual tables, I have shared some of the activities that are successful in other Tables - with the hope of building bridges between the Tables and the adoption of new ideas.

I do plan to continue my travels and my efforts to increase our membership during the coming year. I appreciate the fine support of the members of our State Board and the good work being done by our Standing Committee Chairmen.

May we remain "One for All an All for One", "Una para Todas y Todas para Una".

AUSTIN WILL HOST STATE CONVENTION

The Pan American Round Table of Austin is looking forward to hosting the 53rd State Convention March 22-25, 2007. Over 200 members from Texas and the Mexican border cities are expected to attend. Tables from New Mexico and Oklahoma have also been invited.

Austin hosted a State Convention in 1993. Those attendees remember that Austin is at its loveliest in the early spring.

The meeting will be held at the Hyatt Austin Hotel located near the city center and overlooking beautiful Town Lake. Room rates are as follows: Singles, \$139, Doubles \$149, Triples \$159, and Quadruples, \$169. Self-parking is \$5.00 a day. Information regarding registration and fee is forthcoming.

The opening ceremonies on Friday evening will be held at the Texas State History Museum followed by a dinner. The other meetings will be held at the Hyatt Hotel.

SCHOLARSHIPS AWARDED TO THREE STUDENTS!

There are three outstanding recipients of the Pan American Round Tables of Texas' scholarships for 2006-2007! The members of the Scholarship Committee are: Chairman Dorothy Schatzman, Kay Leech, Gladys Cummins, Jean Hager, Elsie Perez, Margie Rodgers, Geri Rice. Scholarship packets were mailed last August to all the Texas institutions of higher learning – sixty in number. Our website proved to be an invaluable aid for the applicants.

By the January 31, 2006 deadline, ten applications qualified for the scholarship money: Each Scholarship Committee member received copies of the applications of the applicants and ranking forms for voting which were returned to the Chairman who compiled the results.

Maria Teresa Vera Rojas from Venezuela was awarded the Florence Terry Griswold Scholarship I of \$3,000.00. Maria received an undergraduate degree in Literature in 1999 and a Master's Degree in Latin American Literature in 2003 from two universities in Caracas. She entered the doctoral program in US Latino Literature at the University of Houston. Maria Teresa plans to return to Venequela and open a new field of study of US Latino Literature and

Culture. She recognizes the relevance of this study in the context of increased economic associations between countries.

The Florence Terry Griswold Scholarship II was awarded to Debra Ann Cordona. Debra is studying Comparative Politics at Texas A & M University. She will be conducting research in Chile for her dissertation titled "An Analysis of Institutional Interactions in Latin America". She plans to examine judicial authority developments in processes of democratization. The scholarship money of \$2500.00 will help her meet the costs of traveling, living, and working on her project in Chile.

The Melba Dawson Scholarship of \$2,000.00 was awarded to Euraline Williams from Dominica. Euraline attends the University of Dallas and is studying Speech Pathology and Audiology. She plans to return to her native country where there are no speech therapists or audiologists.

All three are most impressive in their accomplishments to date and for those they plan for the future. It will be interesting to hear from the recipients how their studies are progressing. The Pan American Round Tables of Texas has made a significant contribution fo the education of these young women.
